PRODUCT LIMITED WARRANTY - EMCO 400, 300, 200 & 100 SERIES

DOOR FRAME: EMCO Enterprises, Inc. warrants the door frames in its wood core door product against defects in manufacturing, materials or workmanship, under normal use, to the original consumer purchaser who owns the home in which the door was initially installed for a period of twelve (12) years* (aluminum skin over wood core models) or seven (7) years* (vinyl skin over wood core models) from original retail purchase or for as long as the original consumer purchaser owns the home on which the door was initially installed, whichever is shorter. Under normal use, the painted finish on aluminum frame parts is warranted against manufacturing defects and adhesion defects and the functionality of the hinge is covered for as long as the original consumer purchaser owns the home in which the door was initially installed.

*After twelve (12) years from the original retail purchase for aluminum skin models and after three (3) years from the original retail purchase for vinyl skin models, the sole remedy will be the availability to purchase a comparable new door sold by EMCO at 50% of the then current retail price.

COMPONENTS: Door sweeps and the mechanical functions of locksets, closers, windows and insect screens for the wood core door product are warranted for a period of one (1) year from the date of original retail purchase or for as long as the original consumer purchaser owns the home in which the door was initially installed, whichever is shorter. Glass and insect screen fabric are excluded from this limited warranty coverage.

ADDITIONAL PRODUCT LIMITED WARRANTY INFORMATION: In the event a door frame or component fails as a result of a defect in manufacturing, materials or workmanship within the limited warranty period and upon written proof of purchase, EMCO, at its option, will repair or replace the door frame or component without charge. This limited warranty will not apply if the door frame or component has been misused, abused or altered. This limited warranty excludes breakage, corrosion and damage caused by lack of maintenance, exposure to sun and weather, wind, acts of God and normal wear and tear.

BRASS & NICKEL COMPONENTS LIMITED WARRANTY

EMCO Enterprises, Inc. (EMCO) warrants the genuine brass and nickel handle set and sweep to keep their genuine finish for as long as the original consumer purchaser owns the home in which the door containing such brass or nickel parts was initially installed.

The Brass and Nickel Hardware Components Limited Warranty is effective for all applicable doors sold after January 1, 1999. In the event a genuine brass or nickel finish fails under this limited warranty, written proof of purchase of the door and the door serial number must be submitted by the purchaser to EMCO Consumer Support at 1-800-933-3626. EMCO, at its option, will repair or replace the handle set or sweep without charge.

This limited warranty will not apply if the hardware has been misused, abused or altered. This limited warranty does not apply to exterior or interior painted hardware or the function of any lockset or lockset components (see wood core door product limited warranty for complete component limited warranty information). This limited warranty does not include brass or nickel (caming) glass accents.

“OOPS-PROOF” INSTALLATION LIMITED WARRANTY

EMCO Enterprises, Inc. (EMCO) warrants that any part lost or mis-cut during the original installation of your door will be repaired or replaced at no additional charge within ninety (90) days of the date of original purchase. This limited warranty will not apply if the part has been misused, abused or altered. Cutting parts not specified by the installation guide or mis-drilled parts are not included in this warranty.

In the event a part is lost or mis-cut within the limited warranty coverage, written proof of purchase of the door and the door serial number must be submitted by the purchaser to EMCO Consumer Support at 1-800-933-3626 within ninety (90) days of the date of original purchase. EMCO, at its option, will repair or replace the part without charge.

GENERAL LIMITED WARRANTY INFORMATION

This limited warranty is not transferable to subsequent purchasers. Labor is not included in these limited warranties. For consumer assistance under these limited warranties, call 1-800-933-3626.

Replacements and repairs made under these limited warranties are warranted for the remainder of the warranty period applicable to the original product. **ALL IMPLIED WARRANTIES INCLUDING MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE WILL EXPIRE WITH THE TERM OF THE LIMITED WARRANTIES SET FORTH ABOVE. EMCO EXCLUDES AND WILL NOT PAY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES AND ITS LIABILITY WILL IN ALL INSTANCES BE LIMITED TO THE REMEDIES SET FORTH ABOVE.**

These limited warranties gives you specific legal rights, and you may also have other rights that may vary from state to state.
